- 5) Membership Update (Julian) Currently have 185 members of whom 167 are competitive members with 12 Life members.
- 6) Club Constitution- the committee had proposed a simplified criteria for the ballot for the club London Marathon place. The committee felt that the current criteria was too complex and hard to manage as lots of criteria had to be verified which takes a lot of time. They also felt it excluded members of the club who contribute to us getting the two ballot places which they do so by paying to be a member. The criteria did not take into account those people whose seasons could have been affected by injury or personal reasons. The club place chosen by the committee has never been used as it adds a layer of complexity which is politically difficult to navigate. Other changes to the constitution include the use of gender neutral vocabulary and the stipulation that the club members who do gain a LM ballot place must run the event in club colours. A vote was taken and the majority of the club were in favour of these changes so the motion passed.
